Part 1 – CrimEx documents - Objectives (8th and 9th May):

- On the 8th of May, the 2nd CrimEx Session will discuss the reports and the evolution of the Gaps and Legal Analyses and the updates of the EuroMed Fiches carried out in the intersessional activity as recommended by the 1st CrimEx and based on the input received from the SPCs.
- The short-term experts (STEs) will present the draft reports on the above-mentioned documents to CrimEx members for comments and inputs. Representatives of Eurojust, EJN in criminal matters and from other international organisations are invited to present their comments.
- 3. The objectives of the following day, the 9th of May, of the 2nd CrimEx session:
 - a. Based on the main conclusions of the Gaps and Legal Analyses, to decide the best practices and experiences on the measures to improve cross-border cooperation in criminal matters.
 - b. Exchange of views between the STEs, CrimEx, Eurojust, EJN, other international organisations.

- c. Give **main indications** for the elaboration of the **Handbook** on cooperation in criminal matters such as:
 - i. The Manual or Handbook complements the Legal and the Gaps Analyses.
 - ii. The Manual or Handbook on EuroMed judicial and law enforcement cooperation in criminal matters should identify and recommend measures to improve cross-border cooperation, South-South and North-South.
 - iii. The Handbook is designed to be used by central and other competent national judicial authorities, the criminal justice practitioners, including lawyers, investigators, judges and prosecutors who are involved in international legal assistance.
 - iv. The Handbook should offer practical step-by-step suggestions on how to initiate and follow through on the processes of cross-border cooperation as a requesting State and how to respond to, execute and follow up on incoming requests when representing the interests of a requested State.
 - v. The Handbook should contain summaries, case studies and quotes from authors who are leading practitioners and the best practices from organisations specialised in the field of international cooperation in criminal matters.
- d. Plan the intersessional activities (following the agreed procedure) during which the STEs will continue the work and consult with CrimEx members and all other stakeholders on the CrimEx docs' final drafts.

Part 2 – National Platforms - Objectives (10th and 11th May):

- 1. During one day, 10th of May, the participants, supported by Eurojust, EJN, UN (UNODC, CTED) and other international organisations, are invited to debate the challenges and best practices on a holistic national response to transitional crime. The CrimEx will discuss and reflect on the creation of national platforms/mechanisms/centres/poles to facilitate strategic and operational development, information sharing and enhanced coordination among the range of national actors involved in activities that contribute to fighting cross-border crime. CrimEx members should be central to the national platforms.
 - a. CrimEx members will:
 - i. Identify the challenges and the gaps;
 - ii. Promote the exchange of experiences;
 - iii. Obtain best practices;
 - iv. Provide practical regional inputs and mechanisms to the elaboration of recommendations for the creation of national platforms/mechanisms/centres/poles to facilitate strategic and operational development, information sharing and enhanced coordination among the national actors involved in fighting crime.

- 2. On 11th of May the participants will:
 - a. Elaborate the main steps/the roadmap for the creation of the national platforms/mechanisms/centres/poles;
 - b. Conclusions and recommendations on the above-mentioned points.
- 3. A debate will be held in order to encourage participants to identify possible regional needs to be covered by the TAF.

Methodology

- 4. Starting from the introductory documentation prepared in advance and the presentations made by the EuroMed Justice key experts, EU and international experts, and based on the input received from the SPCs, this **interactive** CrimEx Session will **discuss**, **debate** and **decide** on:
 - the draft/outline of the Legal analysis;
 - the draft/outline of the Gaps analysis;
 - the update of the EuroMed Fiches.

CrimEx members shall give main indications for the elaboration of the Handbook.

Elaborate the main steps/the **roadmap** for the creation of the national platforms/mechanisms/centres/poles.
